#### **1      Apologies received**

Apologies from Councillors Mrs. Stonehouse, Dhillon and Elverson, had been received..

#### **2      Absence noted and approved**

The absence of Councillors Mrs. Stonehouse, Dhillon and Elverson was noted and approved.

#### **3      Approval of minutes of Parish Council held on 14<sup>th</sup>. February, 2011**

#### **5      Public session**

The occupants of 16, Pessall Lane advised that they had applied for planning permission to demolish 14 & 16 Pessall Lane but not before a bat survey was undertaken, after 1<sup>st</sup>. May. They informed the Council that a survey had been done in September, that did not reveal any roosting sites and overcame the necessity for a licence. Errors on the dimensions on the drawings had been corrected and concerns over whether some building had commenced, were incorrect. .

#### **6      Clerk's report**

The Clerk reported that the Chairman would be attending a meeting with Mr.. Ellis and traffic authorities at Stafford, to discuss local bus services. A dangerous pot hole on Croxall Road had been repaired and he advised that the number for 'Clarence' was now 03001 118000.  
He had received a letter from Bromford Living (HomeZone) pointing out that the lane on Woodyard Drive would be repaired in April

### **8 Councillor's business**

Councillor Mason advised that the VHMC would not be arranging anything for the Royal wedding, although the pub intended to hold a barbecue. She went on to state that a resident of the Village worked in Sheffield with steel and would be prepared to make the Village sign at cost price. She will advise the Clerk of the details.

The Clerk suggested that, should that occur, then it was essential to apply maximum pressure on LDC to stop the activity immediately, even with the threat of legal action. He went on to state that the applicant had not supplied any additional information, to the original application and there did not seem to have any prospect of success.
